Waller Smith & Palmer PC is located on 52 Eugene O'Neill Dr #6307, New London. From Groton – New London Airport (GON) head north toward State Hwy 649 and turn left onto State Hwy 649. Then turn left onto State Hwy 649/Poquonnock Rd and urn left onto Rainville Ave. Next, turn right onto CT-349 N, keep left at the fork, and follow signs for I-95 S/New London/New Haven and merge onto I-95 S. After that, take exit 84S for CT-32 toward Norwich/New London Waterfront District. At this point, keep left at the fork to continue on Exit 84 S, and follow signs for Downtown New London and merge onto CT-32 S. Finally, Waller Smith & Palmer PC will be on your right.
